# "Terms of use and privacy policy for private investors"

These terms and conditions apply between Amuletum Invest AB (or Amuletum Invest), with org. nr 559376-7196, and the users (professional private investors) of the Amuletum Invest website, located at <a href="https://www.amuletuminvest.com/">https://www.amuletuminvest.com/</a>, with associated services. By becoming a user/customer you accept these terms. If you do not agree to the terms and conditions contained in the Terms of Use and Privacy Policy, please do not access, or otherwise use the site or any information contained herein. By user is meant all professional private investors who uses the Amuletum Invest website, and other information that is provided. If you are an institutional investor, you shall consult the "Terms of use and privacy policy for institutional investors".



# **Membership policy**

### 1. Type of membership

(Professional) private investors can become a user (member) of Amuletum Invest by subscribing to packages of services. Amuletum Invest provides four packages of services from which professional private investors can subscribe to: Amuletum Global Equities Sustainability, Amuletum Global Equities, Amuletum US Multi-Asset and Amuletum Super Private Investor.

### 2. On professional private investors

Following the Securities Market Act (2007:528), a user (member) is considered a professional private investor if the user (member) client has requested in writing from Amuletum Invest to be treated as a professional client, either generally or in relation to a specific investment service, and the client meets at least two of the following three requirements:

1. The client has carried out on average at least ten transactions of significant size per quarter in the relevant market during the immediately preceding four quarters.

2. The value of the client's portfolio of financial instruments, defined as deposits of cash and holdings of financial instruments, exceeds the equivalent of EUR 500,000.

3. The client works, or has worked for at least one year, in the financial sector in a position that requires knowledge of the relevant transactions or services.

### 3. Registration of membership

To become a user, registration of an e-mail address and password is required. By registering, the member guarantees it is a physical- and legal person and that the member is over 18 years of age. It is not permitted for several people to share a membership.

### 3. Login details and password

Each user creates their own username and password, and these details are personal to each individual user. It is not permitted to share login details and passwords with other people. Violation of this condition may result in immediate cancelation of the membership.

# 4. Payment, cancelation, and refund

### 4.1 General subscription information

On Amuletum Invest there are four payment options the user can choose: Amuletum Global Equities Sustainability, Amuletum Global Equities, Amuletum US Multi-Asset and Amuletum Super Private Investor. Payment for subscriptions is handled by Stripe. Amuletum Invest does not store credit card information. All card details for a payment are saved with the payment provider.

### 4.1.1 Monthly subscription

When you pay for a subscription, membership will automatically continue from month to month until canceled. Unless you cancel your membership prior to the monthly renewal date, you agree that the next month's subscription fee will be charged to your payment method (See "Cancelation" below). You will find information about your membership in logged-in mode.

### 4.1.2 Annual subscription

When you pay for a subscription, membership will automatically continue from year to year until it is canceled. Unless you cancel your membership prior to the annual renewal date, you agree that the next year's subscription fee will be charged to your payment method.

### 4.2 Payment methods for Monthly Subscriptions and Annual Subscriptions

You can change the payment method or subscription by logging into the website. If a payment cannot be withdrawn because the payment method has expired, there are insufficient funds, or for any other reasons, and you do not change your payment method or close your account, we may

# **Membership policy**

### 1. Type of membership

Institutional investors can become a user (member) of Amuletum Invest by signing a contract (agreement) with Amuletum Invest to receive the services that are tailored to institutional investors. More specifically, Amuletum Invest can act as an outsourced investment manager (CIO), providing investment strategy solutions and portfolio management services, in addition to its research-based analyses (reports) and investor support services to the user.

### 2. Registration of membership

To become a user, registration of a valid institutional e-mail address and password is required. By registering, the member guarantees it is a legal institution and the user affiliated with the institution is over 18 years of age. It is permitted for a maximum of two people from the same institution to share a membership.

### 3. Login details and password

Each user creates their own username and password, and these details are personal to each user. It is not permitted to share login details and passwords with other people / institutions. Violation of this condition may result in immediate cancelation of the membership and contract.

### 4. Payment, cancelation, and price corrections

### 4.1 Payment information

Payments established in an agreement between Amuletum Invest and the user are made monthly, through monthly invoices sent by Amuletum Invest to the user (institution). The price for the services provided by Amuletum Invest to the user is specified in the agreement.
